RESOLUTION AUTHORIZING EXECUTION OF AGREEMENT WITH SENECA COUNTY FOR LAND BANKING SERVICES

WHEREAS, Seneca County (the "County") has agreed to provide professional services to the Finger Lakes Regional Land Bank Corporation (the "Land Bank") for the purpose of furthering the land banking mission of the Land Bank to engage in various community development and revitalization activities, including the acquisition of vacant tax delinquent properties and returning them to productive use; and


WHEREAS, the agreement specifies the professional services to be provided by the County to the Land Bank which will be primarily staff time, and is attached to this resolution as Appendix "G"; and

WHEREAS, the agreement period is January 1, 2016 through December 31, 2016, and may be renewed annually; now, therefore be it

NOW, THEREFORE, BE IT RESOLVED, by the Corporation that the CEO/President is hereby authorized and directed to sign any and all documents necessary to execute a professional services agreement attached to this resolution as Appendix "G" with the Seneca County for community development and revitalization activities, including the acquisition of vacant tax delinquent properties and returning them to productive use.
