RESOLUTION APPOINTING WILFRED BORDEAU AS VICE CHAIRPERSON OF THE FINGER LAKES REGIONAL LAND BANK CORPORATION


WHEREAS, Article 16 of the New York Not-For Profit Corporation Law (hereinafter the Land Bank Act) and the By-Laws of the Finger Lakes Regional Land Bank Corporation (hereinafter referred to as “the Corporation”) duly adopted on January 26, 2016 permits the Corporation to select a Director of the Corporation to serve as Vice Chairperson of the Board of the Corporation to serve in the Chairperson’s stead in the event of their absence; and

WHEREAS, the Members of the Corporation after due deliberations have selected Wilfred Bordeau to serve as Vice Chairperson of the Board of the Corporation;

NOW, THEREFORE, BE IT RESOLVED by the Corporation that Wilfred Bordeau is selected to serve as Vice Chairperson of the board of the Corporation; and that absent an earlier vacancy in the term of the Vice Chairperson, the term of Vice Chairperson shall end upon the selection of a successor at the Corporation’s annual 2017 meeting, and the qualification of that successor.
