### RESOLUTION REQUESTING THREE PROPERTIES IN VARICK FOR LAND ASSEMBLEGE

**WHEREAS**, the Finger Lakes Regional Land Bank will be requesting parcel 15-1-15.111 from Seneca County prior to the tax auction;

**WHEREAS**, the FLRLBC intends to demolish the condemned residential structure located on tax parcel 15-1-15.111; and

**WHEREAS**, the FLRLBC intends not to expend grant funding on returning this parcel to beneficial use; and

**WHEREAS**, three separate parcels have been identified on the east side of Route 89 that contain a garage, a parking space, and a lake front property; and

**WHEREAS**, the FLRLBC intends to leverage the value of the three properties on the east side of Route 89 to clear the property on the west side; and

**RESOLVED**, that the Finger Lakes Regional Land Bank Corporation's Board of Directors formally request the following parcels in the Town of Varick from the 2019 tax foreclosure list:
