## Finger Lakes Regional Land Bank Corporation Board of Directors

### RESOLUTION ESTABLISHING THE 2020 GOVERNANCE COMMITTEE OF THE FINGER LAKES REGIONAL LAND BANK CORPORATION BOARD OF DIRECTORS

**WHEREAS**, the New York Public Authorities Law S2824(7) requires the Board of the Finger Lakes Regional Land Bank Corporation ("Board") to establish an Governance Committee comprised of not less than three independent members who shall constitute a majority of the committee; and

**WHEREAS**, the bylaws of the Finger Lakes Regional Land Bank Corporation requires that the Governance Committee be comprised of at least three Directors; and

**WHEREAS**, pursuant to the bylaws of the Finger Lakes Regional Land Bank Corporation and New York Public Authorities Law S2824(7), the Members of the Governance Committee shall have the responsibility to keep the Board informed of current best governance practices; to review corporate governance trends; to recommend updates to the Corporation's corporate government principals; to advise appointing authorities on the skills and experiences required of potential board members; to examine ethical and conflict of interest issues, to perform board self-evaluations and to recommend by-laws which include rules and procedures for conduct of board business; and

**THEREFORE NOW BE IT RESOLVED**, by the Board of Directors of the Corporation that:

1. The Members of the Governance Committee shall be Jill Henry (chair), Frank Sinicropi (vice chair), and Melissa Nesbit
2. Unless vacated earlier, the Members of the Governance Committee shall continue to serve until the election of their successors at the 2021 annual meeting of the Board; and
3. That the appointment of the Members of the Governance Committee is effective immediately.
