RESOLUTION TO SELECT MELISSA NESBIT AS THE VICE CHAIRPERSON OF THE FINGER LAKES REGIONAL LAND BANK CORPORATION BOARD OF DIRECTORS

WHEREAS, Article 16 of the New York Not-For-Profit Corporation Law (hereinafter the Land Bank Act) and the Bylaws of the Finger Lakes Regional Land Bank Corporation (hereinafter referred to as "the Corporation") duly adopted on January 26, 2016 permits the Corporation to select a Director of the Corporation to serve as Vice Chairperson of the Board of the Corporation to serve in the Chairperson's stead in the event of their absence; and

WHEREAS, the Members of the Corporation after due deliberations have selected Melissa Nesbit to serve as Vice Chairperson of the Board of the Corporation;


WHEREAS, the Governor of New York has issued Executive Order 202.1 which reads "Article 7 of the Public Officers Law, to the extent necessary to permit any public body to meet and take such actions authorized by the law without permitting in public in-person access to meetings and authorizing such meetings to be held remotely by conference call or similar service, provided that the public has the ability to view or listen to such proceeding and that such meetings are recorded and later transcribed;" and

WHEREAS, this meeting was held on a publicly advertised and available conference call line in compliance with Executive Order 202.1; and

NOW, THEREFORE, BE IT RESOLVED by the Corporation that Melissa Nesbit is selected to serve as Vice Chairperson of the board of the Corporation; and that absent an earlier vacancy in the term of the Vice Chairperson, the term of Vice Chairperson shall end upon the selection of a successor at the Corporation's annual 2022 meeting, and the qualification of that successor.
