### RESOLUTION AUTHORIZING SERVICES AGREEMENT WITH MOZAIC FOR 2126 CHURCH STREET AND 8455 WASHINGTON STREET IN THE VILLAGE OF LODI

**WHEREAS**, the Land Bank has a responsibility to maintain properties it holds in inventory including maintaining the lawns of those properties; and

WHEREAS, under Article XI, Section 162 of the New York State Finance Law, when certain commodity or service offerings, such as lawn maintenance, meet the purchasing needs of a state or local government agency, public benefit corporation and/or some public authorities, those purchases must be made through the Preferred Source Program by contacting New York State Industries for the Disabled Inc. (NYSID); and

WHERAS, MOZAIC is a Preferred Source Vendor and also employs and offers valuable services to many residents of Seneca County which the FLRLBC Board recognizes and wishes to continually support; and

WHEREAS, via Resolution 23-21, the Land Bank previously authorized an expenditure of \$15,506.73 for lawn maintenance for 2023 provided by MOZAIC for eight (8) properties; and

WHEREAS, the FLRLBC is currently under contract with the Town of Lodi as of July 13, 2023 to purchase 2126 Church St. and 8455 Washington St. in the Village of Lodi; and

**WHEREAS**, The FLRLBC would like to add the two properties to the current work order for MOZAIC so they do not become a nuisance prior to closing and so they can be maintained after purchase; and

**WHEREAS,** the CEO/President has followed the NYSID protocol to request a quote from MOZAIC for this service.

NOW, THEREFORE BE IT RESOLVED, by the Finger Lakes Regional Land Bank Corporation that:

1. The CEO/President may sign a work order with MOZAIC for lawn maintenance for all ten properties in inventory provided the total cost does not exceed \$20,000.
